### **Judges:**

Derwent London plc

### **Eligibility:**

## **Terms and Conditions**

1. Entrants: Entry is open to anyone except those directly involved in the running of the competition or judging. Any person, aged 18 years and over, from any country. Anyone under the age of 18 years will be considered upon written receipt of parental consent.
2. Closing date: Entries close on the **23 February 2018**.
3. Entry fees: Free.

5. Equipment: Entries shot on either smartphone, digital or film cameras are eligible.
6. Colour, black & white images and panoramic images are accepted.
7. Age of images: There is no limit on the age of the photograph.
